Thank you for your reply. I will address your concerns from the bottom up of your email.

Canine Concierge Corporation is a community-based nonprofit charitable organization whose fundraising achievements through philanthropists, grants, sponsors, and donations are directed towards hospitals, nursing homes, rehabilitation facilities, senior citizens centers, and police stations, allowing them to reserve time with our specially trained and certified animal-assisted therapy (AAT) dogs and their handlers, free of charge.

Our therapy dogs will provide a wide range of benefits, including lowering the risk and aiding recovery from heart attacks, strokes, and seizures; reducing stress, anxiety, and fear; lowering the risk of other ailments and diseases; creating calmness and lowering blood pressure; encouraging interaction and giving companionship; aiding recovery from those who have PTSD or other trauma; providing a respite from isolation or loneliness; offering comfort and reassurance; helping individuals recover from the loss of a loved one; and creating a sense of well-being and love.

As Canine Concierge is a start-up nonprofit building its business infrastructure since February 2023, my existing hotel suite (since Oct 2021) will house the two therapy dogs and myself. Administrative tasks related to the business will be performed at home, like when I worked in an office. As I am designated "disabled" by the Social Security Administration, I can only volunteer my skills now. After their eight-month off-site training, the dogs will "work" in medical facilities, as expressed above and on our two websites: canineconciergecorp.com | canineconcierge.vip. These therapy dogs will live, eat, play, and exercise with me at home like my other dog did at this hotel before he died in September 2022; nothing different...except these dogs will be professionally certified and designated "working dogs," not pets, and likewise insured.

We do not foresee a human traffic flow at this suite, but it has been retrofitted to accommodate the occasional guest when requested or required, as explained on canineconciergecorp.com. Our staff will be work-from-home independent contractors. We are also still awaiting our 501c(3) IRS tax-exempt status, which we started in March 2023. Without it, we cannot open the doors to solicit contributions because they would not be tax-deductible to a donor unless the amount were \$250 or more. We are registered with the state of Virginia for tax administration.

The legal link on both websites extrapolates all the insurances, permits, licenses, etc., acquired thus far and what remains due to unexpected governmental delays. I have invested five figures into the business, out-of-pocket, and a year's worth of labor, so I am serious about its success.

I will address my working from home business with Mr. XXXXX XXXXXX, the General Manager when he is onsite next week.

The business street address shows that it falls within the Commercial Services Zoning District, which requires a Zoning Appropriateness permit. The ball is in your court on this matter. I submitted the Zoning application on June 10, 2023.
